## **Card Votes**

A card vote is intended to resolve a position where a show of hands is not decisive, to establish the exact breakdown of votes when the majority is of procedural significance (eg two-thirds required) or on a challenge to the Chair. Voting takes place at the end of the session by a show of hands. Where a show of hands is unclear a card vote can be taken having been either requested by delegates or by the decision of the Chair. The decision of the Chair is final.

Constitutional amendments (rule changes) are always decided by a card vote. If a card vote is called the vote is taken immediately so delegates must carry their card vote booklet with them while Conference is in session.

Tellers will pass ballot boxes along each row. Delegates should cast their vote using their card vote booklets by selecting either a FOR or AGAINST card for each vote.

Each card vote in the booklet is numbered. The Chair will announce the number of the card vote being taken.

## **Ballot and card vote results**

The result of card and ballot votes in which all delegates participate are weighted to give 50% of the total votes cast to CLPs and 50% of the total votes cast to other affiliates. Abstentions are not recorded. The results of card votes will be announced to Conference and published in the CAC reports.

## **Composite Motions**

The following composite motions will be debated today

#### **Composite Motion 5 – Brexit**

Conference welcomes Jeremy Corbyn's determined efforts to hold the Tories to account for their disastrous negotiations. Conference accepts that the public voted to leave the EU, but when people voted to 'take back control' they were not voting for fewer rights, economic chaos or to risk jobs. Conference notes the warning made by Jaguar Land Rover on 11.9.18, that without the right deal in place, tens of thousands of jobs there would be put at risk.

Conference notes that workers in industries across the economy in ports, food, pharmaceuticals, manufacturing, energy, chemicals, in our public services and beyond are worried about the impact of a hard Brexit on livelihoods and communities.

Conference believes we need a relationship with the EU that guarantees full participation in the Single Market. The Brexit deal being pursued by Theresa May is a threat to jobs, freedom of movement, peace in Northern Ireland and the NHS. Tory Brexit means a future of dodgy trade deals and American-style deregulation, undermining our rights, freedoms and prosperity. This binds the hands of future Labour governments, making it much harder for us to deliver on our promises.

Conference notes Labour has set six robust tests for the final Brexit deal. Conference believes Labour MPs must vote against any Tory deal failing to meet these tests in full.

Conference also believes a no-deal Brexit should be rejected as a viable option and calls upon Labour MPs to vigorously oppose any attempt by this Government to deliver a no-deal outcome. Conference notes that when trade unions have a mandate to negotiate a deal for their members, the final deal is accepted or rejected by the membership. Conference does not believe that such important negotiations should be left to government ministers who are more concerned with self-preservation and ideology than household bills and wages.

Stagnant wages, crumbling services and the housing crisis are being exacerbated by the government and employers making the rich richer at working people's expense, and not immigration.

Conference declares solidarity and common cause with all progressive and socialist forces confronting the rising tide of neo-fascism, xenophobia, nationalism and right wing populism in Europe.

Conference resolves to reaffirm the Labour Party's commitment to the Good Friday Agreement of 1998 including no hard border in Ireland.

Conference believes that there is no satisfactory technological solution that is compliant with the Good Friday Agreement and resolves to oppose any Brexit deal that would see the restoration of a border on the island of Ireland in any form for goods, services or people.

Should Parliament vote down a Tory Brexit deal or the talks end in no-deal, Conference believes this would constitute a loss of confidence in the Government. In these circumstances, the best outcome for the country is an immediate General Election that can sweep the Tories from power.

If we cannot get a general election Labour must support all options remaining on the table, including campaigning for a public vote. If the Government is confident in negotiating a deal that working people, our economy and communities will benefit from they should not be afraid to put that deal to the public.

This should be the first step in a Europe-wide struggle for levelling-up of living standards, rights and services and democratisation of European institutions Labour will form a radical government; taxing the rich to fund better public services, expanding common ownership, abolishing anti-union laws and engaging in massive public investment.

#### **Composite Motion 6 - Government Contracts**

Conference notes the government's emergency takeover of Birmingham Prison from G4S on August 19th, the latest in a long line of public services brought back under public control. Conference welcomes Labour's opposition to the failed PFI experiment, a relic of the New Labour years which should be abandoned. Conference believes that the privatisation of public services has proven to be a failure both in terms of service provision and for all of those working in public services. Conference believes that returning public services to public control is the best solution financially, morally and in terms of service delivery. Conference therefore welcomes Labour's new Community Wealth Building Unit to promote insourcing and the actions of the Labour administration in Wales in encouraging public in-house provision. Conference resolves that: Labour should oppose all privatisation of public services, PFI and the use of wholly owned subsidiary companies by public bodies and advocate the return of all public services to public-control within the first year of the next Labour government; In bringing services in-house the minimum standards for pay, terms, conditions and pension arrangements must be those sector wide arrangements secured through collective bargaining - including pay of at least the real living wage; There will be a moratorium on any further privatisation by Labour-controlled local authorities, and that all Labour Groups be written to by the Labour Leader calling on them to bring services back in house at the earliest available opportunity.

#### **Composite Motion 7 - Government Contracts**

Conference notes with alarm further moves by police and crime commissioners (PCCs) to take control of fire and rescue services, most recently on 6 September when legislation was laid to give the North Yorkshire PCC control of fire services. Conference believes that PCC takeovers of fire and rescue services could create a backdoor route to privatisation. Conference notes the privatisation of other areas of the fire and rescue service, such as the Fire Service College, PFI contracts for fire service premises and vehicles, and the training of firefighters in some brigades. Conference further notes that one-in-five firefighter jobs have been cut across the UK since 2010. Conference believes that returning public services to public control is the best solution economically, politically and in terms of service delivery. Conference welcomes Labour's commitment to bring back provision in-house of all public services. Conference calls for immediate investment in locally-provided public services, as part of a programme to repair the damage done by austerity. Conferences calls on the next Labour government to bring privatised services back into the public sector within the first year of its administration. Conference calls for a halt to any further privatisation by Labour-controlled local authorities and for Labour-controlled authorities to urgently begin the process of bringing any privatised back inhouse.

#### Composite Motion 8 – Justice for the Windrush Generation

Conference notes:

1. The 10 August Guardian report that dozens of Windrush citizens wrongly targeted by the government over their immigration status are still waiting for their cases to be resolved.

2. On 9 August representatives of 20 churches wrote to the Home Secretary condemning the hostile environment as inhumane, unjust and causing racist discrimination.

3. On 7 August Labour-run Hackney Council became the first local authority to pass a motion pledging to oppose the criminalisation of Windrush families, celebrate annual Windrush Day and press central Government for a public enquiry into the scandal.

Conference demands the government resolve the outstanding cases now. Commonwealth citizens who came here before 1973 are British citizens. They and their relatives should not have been detained, deported, denied re-entry to this country, lost their homes, jobs and livelihoods.

Conference condemns the 'hostile environment' policy that treats these British citizens, and others entitled to be here, as illegal immigrants, and deplores the role of Theresa May in developing the policy of 'deport first, appeal later.'

Conference supports:

 The Labour leadership's success in exposing these cruel and discriminatory policies and of forcing the resignation of a Tory Home Secretary.
Labour's policies to end the 'hostile environment' policy; close some detention centres and end indefinite detention; fully compensate the victims; and to demand that the Government makes immediate interim hardship payments.
The incoming Labour government scrapping the Immigration Act of 2014 which enshrined the 'hostile environment' into law.

#### **Composite Motion 9 - Palestine**

Conference notes

The Guardian of (31 August) reporting the Trump administration's confirmation of funding cuts to UNRWA, which provides emergency assistance and basic provisions to Palestinian victims of the Nakba of 1948, when the majority of

Palestinian people were forcibly displaced from their homes.

As UNRWA's largest donor, this US decision is widely understood (Guardian 31 August) as the means to "unilaterally sweep aside" one party to the conflict, get rid of the "main sticking point": the international rights of the Palestinian people who are now refugees.

Britain's direct role in the terrible fate of the Palestinian people, who still seek their internationally protected rights to self-determination, and to return.

That UNRWA, established by UN General Assembly resolution 304 of 1949, derives its mandate directly from UN member states to serve Palestinian refugees until their rights are addressed, in a peace process underpinned by the principles of international law.

For several months, thousands of Palestinians have engaged in mass and overwhelmingly non-violent protests in the Gaza Strip.

On Friday the 10th August a volunteer medic Abdallah al-Qatati was shot and killed by an Israeli sniper while on duty during Great March of Return

On Friday 17th August another medic Karim Ahmad Ali Fatayer, 28, was fatally shot in the head when Israeli soldiers opened fire on unarmed protesters near the boundary fence. More than 100 others were shot with live ammunition that day on Friday.

The Government of Israel has responded to the protesters with heavy repression.165 Palestinians have been killed. Of these, 122 were killed in protests, including 21 children, two journalists, four paramedics, and three people with disability. Another 8,875 people were injured, including 1,611 children, 399 women, 90 paramedics, and 82 journalists; those injured, 4,952 people were hit by live fire.

#### Conference condemns

This aggressive attempt to rewrite history, and erase the victims of the 1948 war, who were expelled or fled from their homes in Palestine Conference supports

Developing solidarity with Palestinian refugees, especially young refugees, and to explore developing links with UNRWA schools, its training centres, and its

local staff serving across the Middle East

Conference urges

The British government to increase its level of annual assessed contributions to UNRWA, providing much needed reassurance and stability to Palestinian refugees, and to encourage other member states to do the same. This conference resolves to call for

an independent international investigation into Israel's use of force against Palestinian demonstrators; a freeze of UK Government arms sales to Israel; and an immediate unconditional end to the illegal blockade and closure of Gaza.

## **Appendix 3 – Emergency Motion**

#### **Build Our Royal Liverpool Hospital**

Conference notes that on the 17<sup>th</sup> September 2018, the Liverpool Echo reported that the 'longstop date' for the stalled Royal Liverpool Hospital is the September 30, 2018, meaning that the entire hospital construction project could be declared in default, likely to be followed by a complete termination of the current contract.

Conference further notes the reporting on the 12<sup>th</sup> September revealed that some of the cladding installed on the new building did not satisfy fire regulations.

**Conference** notes that the complex fallout from the insolvency of Carillion PLC could take years to resolve.

Conference states its anger and frustration that Government has left its citizens using facilities that are not fit for purpose for the health requirements of a modern city.

Conference therefore believes that the only remedy that will succeed is: The Government takes direct control of the project and ensures that the construction of the site is completed as swiftly as possible with the necessary public funding.

The Government ensures that, so far as possible, any losses arising from the collapse of Carillion PLC are born by the private sector (relevant insurers and investors in the project who accepted the commercial risks of the project) and not the public purse.

Finally, Conference welcomes the unified support from the Mayor of Liverpool, Liverpool City Council, unions including UNITE, UNISON and GMB, the city's Members of Parliament, the Metro Mayor, patients groups and local campaigners such as Keep Our NHS Public on this campaign.
